

Unemployment rate, not seasonally adjusted




2. Unemployment rate comparison between the US, Washington, and Whitman County.



Clean Energy Projects in Rural Counties May Increase Property Taxes for Residents

Washington is a leader in clean energy projects. An unfortunate unintended consequence is that property owners in areas where clean energy projects are built will likely see increased tax bills. The benefits realized by local communities from the development of clean energy production facilities have long been a source of controversy, especially in rural areas. While county governments and other local services like schools and fire districts will receive increased property tax revenue, a significant portion of the new revenue from clean energy project development can ultimately become the responsibility of others to pay. The state's property tax assessment process can result in large annual value fluctuations and significant depreciating values over time that shift the projects' tax burden to the other residents and businesses in the taxing district.

Recent State Legislation Driving Clean Energy Project Development:

- The Energy Independence Act of 2006 requires qualifying electric utilities source up to 15% of their electricity from renewable energy.
- Washington Clean Energy Transformation Act (2019) requires all electricity sold in Washington to retail electric customers to be from 100% non-greenhouse gas emitting or renewable resources by 2045.

Key Findings: Unveiling the Challenges and Implications

- 1 Increased Clean Energy Development: Washington State's ambitious climate policies have led to a surge in proposed clean energy production facilities in rural counties. However, much more will be needed to meet the state's goals.
- 2 | Inconsistent Property Tax Assessment: The state's property tax assessment process for centrally and locally assessed clean energy projects results in inconsistent assessed values, posing challenges for fair taxation.
- Tax Burden Shifts: Washington's personal property tax laws create tax burden shifts over time from clean energy projects to other property taxpayers within the same taxing districts, placing an additional tax burden on existing property taxpayers.
- Fluctuating Assessed Values: Clean energy project assessed values experience significant fluctuations annually due to assessment methods and over longer periods owing to personal property depreciation. As a result, over half of their property tax responsibility has been shifted to other taxing district property taxpayers, amounting to millions of dollars in property tax shifts.

2024 FEDERAL LEGISLATIVE PRIORITIES

U.S. Highway 12 - Phase 8

Funding for U.S. Highway 12 four-laning Phase 8. Total federal funding needed for construction is \$280 million. The state has already earmarked \$21.8 million for design and right-of-way acquisition. Seeking Phase 8 placement on the Federal Highway Administrations Projects of National and Regional Significance. Work with congressional delegation to have project listed as a Tier I or Tier II project.

U.S. Highway 12 - Clinton Interchange

Funding for the U.S. Highway Clinton Street Interchange. Total funding needed for design, environmental, permitting, land acquisition and construction is \$73.8 million. Project will construct an interchange to provide full access at Clinton Street to enhance safety, community connectivity, economic vitality, and provide a safe and full access for freight mobility.

Jonathan M. Wainwright Memorial VA Medical Center

Funding to ensure services for our region's veterans are maintained at Johnathan M Wainwright Memorial VA Medical Center.

<u>Full Support of the River Navigation System, including Full and Proper Maintenance of the Columbia and Snake River Dams</u>

The Columbia and Snake River navigation system is critical infrastructure to the Pacific Northwest economy. Full protection of the navigation system is paramount to the continued economic vitality of the Pacific Northwest. Proper ongoing maintenance ensures the longevity of the system and will allow for continued use and benefit of the inland waterway.

Regional Wastewater Treatment Plant

Funding for the development and construction of a regional wastewater treatment solution that could benefit the City of College Place, City of Walla Walla, and Port of Walla Walla. As our communities grow, there are greater and evolving demands on our current systems. Both Walla Walla and College Place are on the cusp of significant improvements to their Wastewater Treatment Plant (WWTP) facilities; therefore, right now represents a unique time to partner in the development of a regional solution.

Walla Walla Water 2050

The Walla Walla Water 2050 initiative has been authorized by the Washington Legislature as an effort to improve streamflow's and water supplies in the Walla Walla River Basin over the next 30 years. The State of Washington has pledged to provide up to 50% of the costs, therefore we are seeking federal funds as a match.

Walla Walla County Courthouse

The County's Historic Courthouse Complex is both the operational and visible seat of County government. The County has received a threat analysis from DHS/CISA on the physical resiliency of the complex. The need to secure the courthouse with more robust physical protection, as well as the need to transition to a single-entry complex was very clearly stated.

Walla Walla Watershed Protection

Support funding for the US Forest Service to improve wildland fire fighting capacity and fire prevention through fuel reduction in the Walla Walla watershed. Further, the delegation supports including wildland fires as a natural disaster to qualify affected communities for Federal and State disaster relief assistance.

Wallula Gap Business Park Development

The Wallula Gap Business Park is ±1,500 acres of industrial zoned property that needs infrastructure improvements for industrial business recruitment leads. Infrastructure needs include: Expansion of a potable water system, additional wells for reliability and redundancy, fire flow capacity for large manufacturing facilities, wastewater disposal system (large storage reservoirs for land application) and the construction of a roadway and railroad network system to serve the park.

Mill Creek Channel (Not a federal request, just a progress update)

The Mill Creek General Investigation Study is complete, and the Corps of Engineers moved the project to the Continuing Authorities Program (CAP) Section 205 based on the estimated project cost of approximately \$10M. The Mill Creek Coalition and the non-federal sponsor have secured matching funds, and the Corps of Engineers anticipates design will begin in early 2023 with construction occurring over two annual fish windows, in 2024 and 2025.

Commercial Air Service (Airlines Support)

Keep congressional delegation updated on Alaska Airlines marketing and retention efforts. Port/Airport may want to start exploring another Small Service Community Air Service Grant for a second outbound destination or retention of existing service.

<u> Airport Improvement Program – Local Match</u>

Small rural airports like Walla Walla Regional Airport are having a hard time coming up with their local match requirement for large FAA projects (current funding formula is 91.88%/8.12%). A 95% Federal and 5% local funding formula would help small airports complete critical infrastructure projects.

Broadband

Support funding broadband infrastructure and providing incentives in rural cities/towns of all sizes to foster economic development and provide greater technological equity with the urban centers.

Emergency Operations Center Improvements

Walla Walla County's multi-agency Emergency Operations Center has been identified as a targeted damage site, as it lies in the collapse path of a multi-story brick structure that could render the site a total loss to all law enforcement and the Emergency Operations Center. A new location has been identified that would increase the region's emergency resiliency.
