Catering proposals for the Port of Whitman County's (Port) Snake River Family Festival (Festival) held at Boyer Park and Marina, 1753 Lower Granite Rd, **Colfax, WA 99111**, on **Saturday, June 8, 2024, from 11:00 a.m. – 3:00 p.m.** are being accepted. About the event: The Port is hosting the seventh-annual Snake River Family Festival. The Festival is a family-friendly event and is free to the public. The Port's mission in hosting the Festival is to educate attendees about the benefits, both recreational and economic, of the existing multi-use Columbia Snake River system. Catering proposals should address the following event needs:

- 1) Food and non-alcoholic beverages for **500** people
 - a. Ready-to-serve for quick and easy service to attendees
 - b. Picnic or BBQ style is suggested
- 2) All service items, including ice, serving dishes and equipment, plates, utensils, napkins, cups, etc. to be provided by caterer
- 3) Serving tables and optional linen, decorations, etc. to be provided by caterer
- 4) Electric extension cords, if needed, to be provided by caterer
- 5) Tent to cover the service area. Can/will caterer provide?

The Port and/or the venue will provide:

- 1) Electricity (please detail needs in the proposal)
- 2) Flat paved area for set up and serving
- 3) Temporary food permit as needed

RFPs must include:

- 1) Detailed menu
- 2) Detailed cost breakdown
- 3) Detailed payment schedule
- 4) Detailed plan to address unconsumed food

Budget:

The inclusive budget for catering for the Festival is **\$10,000**.

RFPs will be evaluated based on proposed menu, overall cost and meeting of the needs listed above.
